Treasure's Update

As we closed the books on 2021 I can report that the finances of the WNNA are on a solid foundation. Our 'operating account' ended 2021 with a positive balance of approximately \$28,600 and we begin 2022 with approximately \$120, 400 in the 'reserve fund'.

Income in 2021 was approximately \$155,500 exceeding the budgeted amount by 9% while expenses of approximately \$115,000 came in under the budgeted amount by 11%.

FYI the budget for 2022 was approved at the Fall 2021 meeting and is exactly the same as 2021. There will be a significant increase in income as the \$100 increase in the general dues takes effect his year. These additional funds will be placed into the 'reserve fund' for future capital improvement projects.

Please remember that 2022 association dues are due by March 31, 2022.

My apologies for 'typo' in the dues forms that were sent out early in February and big 'Thank you' to my predecessor Rob Place for posting the correction notice on the neighborhood Facebook page and for his many years of service to the association!!
